WHEREAS, 5324 Rt 38 Pennsauken Land Holdings, LLC ("Lessor") is the fee owner of the real property commonly known at 5324 ROUTE 38, PENNSAUKEN, NJ 08109 (Block 6113, Lot 5); and

WHEREAS, 5324 Route 38 Pennsauken Land Holdings, LLC, and the Township of Pennsauken ("Lessee") are parties to a Monument Display Operating and Maintenance Agreement dated April 24, 2020, by and between 5324 Route 38 Pennsauken Outdoor, LLC and the Township; and

WHEREAS, Lessee desires to lease from Lessor and Lessor desires to lease to Lessee, subject to the terms and conditions set forth in the attached Non-Exclusive Ground Lease Agreement (Exhibit "A" hereto), a portion of Lessor's Property where the monument display is located in order to facilitate Lessor's performance of its obligations and exercise of its rights under the Monument Display Operating and Maintenance Agreement; and

WHEREAS, Lessee desires to promote the Township of Pennsauken by having the Township's official seal on the Lessor's property; and

WHEREAS, the Lessor's property will contain public service messages and emergency messaging which will provide a public purpose; and

WHEREAS, this Non-Exclusive Ground Lease Agreement will promote and facilitate this public purpose; and

WHEREAS, the Local Lands and Buildings Law, <u>N.J.S.A.</u> 40A:12-5, requires that the lease of real property by a public entity be authorized by Ordinance, and it is the desire of the Township Committee to enact this Ordinance authorizing same to comply with the terms and conditions of the Local Lands and Buildings Law.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Township Committee of the Township of Pennsauken, County of Camden, and State of New Jersey, as follows:

ARTICLE I. AUTHORIZATION TO ENTER INTO LONG-TERM NON-EXCLUSIVE GROUND LEASE AGREEMENT WITH 5324 ROUTE 38 PENNSAUKEN LAND HOLDINGS, LLC

The Township Committee hereby authorizes the lease of a long-term leasehold interest in property owned by 5324 Route 38 Pennsauken Land Holdings, LLC at Block 6113, Lot 5. The Committee further authorizes the execution of such documents as may prove necessary for the Non-Exclusive Ground Lease Agreement. Said lease of land by the Township shall be subject to a Non-Exclusive Ground Lease Agreement between the Township and 5324 Route 38 Pennsauken Land Holdings, LLC. The lease of the interest in the property known as Block 6113, Lot 5, also known as 5324 Route 38, shall be for a period of twenty-five (25) years.

WHEREAS, matters under discussion will not be disclosed until the need for confidentiality no longer exists; and

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of Pennsauken, pursuant to the Open Public Meetings Act of the State of New Jersey that:

- 1. The Township Committee of the Township of Pennsauken shall hold a closed meeting from which the public shall be excluded, on June 17, 2021.
- 2. The general natures of the subjects to be discussed at said closed meeting shall be matters of contracts N.J.S.A. 10:4-12b (7)

RESOLUTION DECLARING A DEFAULT OF SOUTH JERSEY SANITATION / SEASIDE WASTE SERVICES FOR FAILURE TO PERFORM CONTRACTUAL OBLIGATIONS AND AUTHORIZING NOTICE OF DEFAULT TO THE SURETY COMPANY

WHEREAS, the Township of Pennsauken has a Contract for Solid Waste & Recyclables Collection Services with South Jersey Sanitation Company, Inc. (SJS) which commenced on January 1, 2019; and

WHEREAS, the Contract concerns the collection of trash, waste, and recyclable materials by SJS from residential properties within the Township, as well as various municipal locations; and

WHEREAS, the Contract was entered into by the Township and SJS after the solicitation of bid proposals from various solid waste collectors; and

WHEREAS, per the Township's Instructions to Bidders, SJS was obligated to provide a performance bond pursuant to the Contract. A performance bond from the surety Hudson Insurance Company was submitted by SJS, for the years 2019, 2020 and 2021; and

WHEREAS, on or about March 1, 2021, the Township was advised that SJS had been sold and the company was rebranded to "Seaside Waste."

WHEREAS, SJS/Seaside Waste has repeatedly failed to perform its contractual duties; and

WHEREAS, the Township has received a myriad of complaints from Pennsauken residents concerning SJS/Seaside Waste's failure to perform their basic contractual duties. SJS/Seaside Waste has repeatedly missed trash pick-ups, recycling pick-ups, yard debris pick-ups, metal pick-ups and has generated a large number of general customer complaints; and

WHEREAS, the Pennsauken Department of Public Works employees have needed to assist SJS/Seaside Waste in the performance of their contractual obligations; and

WHEREAS, the Township hereby declares SJS/Seaside Waste to be in Default under the Contract; and

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Pennsauken, New Jersey, that SJS/Seaside Waste is hereby declared in default of the Contract for Solid Waste & Recyclables Collection Services for failure to perform; and

BE IT FURTHER RESOLVED, that the governing body of the Township of Pennsauken, New Jersey is hereby authorized to provide notice to SJS/Seaside Waste and the surety company of the default of SJS/Seaside Waste

Committeewoman Roberts moved the motion to table resolution after coming back from closed.

Committeeman Martinez seconded the motion. An affirmative 4/0 voice vote was recorded.
