MINUTES TOWNSHIP OF PENNSAUKEN TOWNSHIP COMMITTEE MEETING SEPTEMBER 3, 2020

The Committee Meeting of the Pennsauken Township Committee was held via ZOOM electronic participation on Thursday, September 3rd, 2020.

The Meeting was called to order by Mayor Killion at 6:00pm. The number of COVID cases within the Township has reached 923 cases and a total of 23 deaths. Mayor Killion expressed his thoughts, concerns and prayers for families affected by the virus and for the families who have lost loved ones. He continues to stress the importance of wearing your mask and social distancing.

Mayor Killion called for the Salute to the Flag followed by a Moment of Silence and announced the "Senator Byron M. Baer Open Public Meetings Act" keeping the meeting in compliance with state laws.

Special request for electronic participation in the Meeting due to current Covid-19 Pandemic.

Committeewoman Rafeh moved the motion to participate via ZOOM. Committeeman Dyer seconded the motion. An affirmative 5/0 voice vote was recorded. *Motion passed.*

The Meeting commenced with a roll call by the Township Acting Clerk.

PUBLIC COMMENT

Mayor Killion commented, Mayor Moran is a man of his word.

<u>Ellyn McMullen</u> of Palace Court, questioned if the Township has two new administrators what now happens to Joe Palumbo's position.

Mayor Killion stated that there is a restructuring of the Township organizational flow and instead of 20 people reporting to one person, who also supports Township committee. We are striving to continue to provide great service to our residents and the daily operation.

Deputy Mayor DiBattista moved a motion to close the floor to public comment Committeewoman Rafeh seconded the motion An affirmative 5/0 voice vote was recorded

COMMITTEE COMMENTS

Mayor Killion

Commented on the Grand Opening and ribbon cutting ceremonies he attended over the weekend.

The Mayor gave "kudos" to former Committeemen Taylor, Killion and Committeewoman McBride for the continued partnership with Volunteers of America for affordable housing for Veterans at Britton Village. He thanked Congressman Norcross, former members of Committee and Bernie Kofoet for their support.

Mayor Killion commented on the Variety liquidation grand opening on Westfield Ave. and the 25th Anniversary of the passing of George Bowman.

He asked that everyone continue to wear their mask and practice social distancing.

Deputy Mayor DiBattista

Thanked those who participated on the ZOOM call and stated his thoughts and prayers are with the families dealing with the COVID virus.

Mr. DiBattista stated there will be two car parades on September 19th the first to begin at 12 noon and the second one to begin at 1:30 pm to practice social distancing.

He also commented on the lemonade for change drive.

Committeewoman Rafeh

Thanked the residents for participating in the meeting. She thanked the Mayor and Committee for their support of the Library and stated the next lemonade drive by will be at Delair School on September 12th, between 1 and 3 pm. The library will be conducting virtual story time for pre-K beginning September 15th through the 29th between the hours of 11am and 11:30 am.

She asked everyone to stay diligent wearing their mask.

Committeewoman McBride

Commented that she was sorry she couldn't attend the ribbon cutting at Britton Village due to self-quarantining but was very happy to see it finally come to fruition.

Mrs. McBride again stated the importance of completing the Census forms. She requested the Administration and staff push the census when answering the phone through September. The Township is currently at 70.7% completed responses.

Committeeman Dyer

Sent his prayers to those families affected with COVID. He continued to urge everyone to stay vigilant and continue to wear their mask; Restaurants are opening at a 25% capacity and schools are on a hybrid opening. He also wished Committeewoman Rafeh good luck with her delivery of her first child.
