RESOLUTION RESCINDING AWARD OF FOOD AND BEVERAGE CATERING LEASE AT PENNSAUKEN COUNTRY CLUB TO 3800 HADDONFIELD AND AUTHORIZING EXTENSION CONTRACT WITH MARCO'S RESTAURANT, INC.

WHEREAS, The Township of Pennsauken ("Township") and Marco's Restaurant, Inc. ("Marco's") entered into a Contract pursuant to a Competitive Contract Request for a Proposal for food and beverage service at the Pennsauken County Club as authorized by Pennsauken Township Resolution #2017-142, (Contract"); and

WHEREAS, said contract expires on June 30, 2022; and

WHEREAS, with a due date of April 28, 2022, the Township issued a competitive contract Request for Proposal as authorized by the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. for food and beverage service at the Pennsauken Country Club to begin July 1, 2022. The Township did not receive any responses to this Request for Competitive Contract Proposal; and

WHEREAS, thereafter, the Township issued a second Competitive Contract Request for Proposal for a food and beverage service at the Pennsauken Country Club which was due on May 25, 2022. On May 25, 2022, the Township received two responses to this Request for Competitive Contract Proposal; and

WHEREAS, by Resolution Number 2022:241 dated June 2, 2022 the Township approved the award of the food and beverage service contract to 3800 Haddonfield; and

WHEREAS, after the award of the contract, representatives of 3800 Haddonfield advised the Township that it was unable to fulfill the terms of its response to request for competitive contract proposal and were unwilling to enter into the contract for food and beverage service at the Pennsauken Country Club; and

WHEREAS, the Township now seeks to rescind the award of the food and beverage service contract to 3800 Haddonfield and Resolution Number 2022:241 because 3800 Haddonfield has advised the Township that it is unable to fulfil the terms of the award and unwilling to enter into the contract; and

WHEREAS, the Township now seeks to continue its contractual relationship with Marco's and enter into an extension contract for a period of six (6) months while the Township re-bids the food and beverage service contract. Marco's has requested and the Township has agreed to reduced monthly rent during that time period so that Marco's can advertise, market and recruit new staff members; and

WHEREAS, this extension contract is in the best interest of the Township; and

NOW, THEREFORE, BE IT RESOLVED on this 16th day of June 2022, by the Township Committee of the Township of Pennsauken, County of Camden and State of New Jersey, that,

- 1. The Township rescinds the award of the contract to 3800 Haddonfield and Resolution 2022:241 due to the representations of 3800 Haddonfield that it is unable to perform the terms of its bid proposal received on May 25, 2022;
- 2. The Township is authorized to enter into an extension contract with Marco's Restaurant, Inc. for a period of six (6) months while the Township re-bids the contract with the hope of gaining favorable proposals through competition among vendors;
- 3. The Mayor and/or Township Administrator of the Township of Pennsauken are authorized to execute the extension contract on behalf of the Township of Pennsauken in a form sustainably similar to the attached; and

BE IT FURTHER RESOLVED, that the Resolution and the extension contract be kept on file with the Township Clerk and available for public inspection.
